ASSESSMENT APPEAL FORM

This Assessment Appeal Form is completed by students wishing to appeal the outcome of an assessment (see Reasons for Appeal below).

- Assessment Appeal Forms are located on the Wellpark website or you can email faculty.support@wellpark.co.nz for a copy.
- This Form is to be handed in to the Receptionist, who will sign and date it and then forward to Faculty Support or you can email directly to faculty.support@wellpark.co.nz for processing
- The Form will be passed onto the Self-assessment Team for action.
- Assessment appeals must be made within 2 calendar weeks of receiving the formal grade.
- Neither the assessor/marker nor your Tutor is able to progress an Assessment Appeal.
- You will be advised of the outcome by email within 10 working days of receipt of your Appeal.
- If there is still no resolution, College Management will refer the matter to a qualified and external assessor for adjudication, whose decision will be final (unless the student chooses to appeal to NZQA – see DEALING WITH CONCERNS).
- As part of the appeal process your assessment may be blind marked by another assessor and that, if you are applying on the grounds that you disagree with the marking, the assessor finds you were awarded too many marks you may lose marks on your assessment and have the new grade recorded on your records.

Complete the Form, attach the appropriate documentation and return to Reception by advised date. Receptionist is to sign and date the Form with the student present, prior to handing in to Faculty Support.
